FORMATION OF GOVERNING BODY

The Governing Body (GB) is formed as per the guidelines of AICTE, New Delhi and RGPV Bhopal. Objectives:

The Society/Trust, which has established the Institution, shall exercise its control in the institution through the Governing Body.

Function, Role & Responsibility:

The GB is responsible for the management of the Institution. Its function shall include the following:

- a) To form various Committees.
- b) To approve the budget estimates recurring and non-recurring for the financial year in advance.
- c) To scrutinize and accept the audited statement of account for each year.
- d) To estimate the work load, approve the staff pattern and create posts-teaching and non-teaching (Technical and administrative) for the Institution.
- e) To consider and approve the proposals for creation of infrastructure such as building, equipment, Library and staff on a continuous basis.
- f) To Consider and make provisions for meeting the general and specific conditions laid down by AICTE, The State Government RGPV, Bhopal and monitoring the progress in fulfilling the conditions:
- g) To consider the report of the Principal on status of admissions:
- h) To consider the report of the Principal on the academic performance of the students.
- i) To supervise the observance of service Conditions of the staff as prescribed.
- j) To consider the proposals of the Principal for improvement in academic performance of the staff.
- k) To consider any other matter which enhance the academic atmosphere in the institution.
- To consider any proposal for expansion of educational activities to be made to the AICTE/Government/RGPV Bhopal.

The Meeting of Governing Body will be held 2 times in a year. The meeting of the Committees should be held as often as required. The Principal of the institutions, who is the members Secretary, shall be responsible for organizing the meeting as required. The notice of the meeting should be sent to all the members so as to reach them at least 15 days in advance. The agenda papers with details should reach the members at least a week in advance. Principals shall be responsible for preparing the minutes of the meeting.

Commencement of 07th Semester B.Tech. The semester will likely to start from first from week of July and 100% course coverage will be ensured by first week of Nov. The course conduction was planned. The point is appreciated and noted.

Commencement of 3rd & 5th Semester B.Tech. and 3rd Semester of M. Tech. The semester will star likely from first week of August and 100% course coverage will be ensured by first week of December 2023. The course was planned for smooth conduction. The point is well appreciated and noted.

Admission in 1st Year. Item No. 6. General information about infrastructural development and miscellaneous issues:


Implementation of new fees structure:

The Fees structure for various B.Tech and M.Tech courses has been received from AFRC order dated 12/09/2022. In this letter fee regulation for students admitted in Academic session 2023-24 & 2024-25 is mentioned. We will follow the same for taking the fees from the students.

Budget estimation for the year 2023-24:

Member secretary presented the budget for the financial year 2023-24. It is approved by the members of the Committee.

Construction of Building: The Construction of Hostel building and another building for class rooms has already started last year in November 2022. It is under progress right now. The

budget allocated for these project last year was approximately 6 Cr. each out of the total of 16 Cr. allocation for building construction and maintenance.

<u>Provision of Bus Services:</u> The Bus services are provided to students and staff for coming to the College and going back home in Bhopal and also to and fro from nearby places like Sehore, Vidisha &Raisen.

<u>Battery operated Cart:</u> Battery operated Carts are operational inside the LNCT Campus for movement of staff, faculty and visitors.

Renovation of Auditorium: The renovation of Auditorium building to enhance the capacity and facilities such as audio, light & AC arrangement has started in 2022 with allocation of approximately 3 Cr. The work is under progress.

<u>Procurement of Kiosk Machines:</u> 02 Kiosk Machines are procured for facilitating the registration process of the students.

At the end, the Chairman and members expressed their happiness for the good work faculties and staffs are doing in constantly enhancing and maintaining the quality of the College. They advised to work always towards being the best. They further advised to make all out endeavor to maintain and also bring best practices and bring more and more laurels to the College.


